## Part 1: Philosophy Statement: 400 words

The way I would resolve conflicts in relation to copyright and copyright limits would be to follow laws already in place and make sure that professionals know these laws and are aware of copyright limits when making a case. I would make sure that all parties involved know the copyright laws of the country in which they are applying these laws. For example, in The United States, The copyright law of 1976 states that, "the public printer shall sell under regulations for the Joint Committee on Printing to persons who may apply, additional duplicate or stereotype or electronic plates from which a Government publication is printed, at a price not to exceed the cost of composition, the metal, and making to the Government, plus ten per centum, and the full amount of the price shall be paid when the order is filled," (Copyright.gov). I am assuming this relates to coin mint or photographic printing. It shows and can be seen that there are laws in place regarding copyright which can be followed in case of a dispute over intellectual rights. One societal barrier which could come up in such a case would be what country the person who is seeking copyright lived in. If the person seeking copyright lives in a country beside the United States of America, copyright laws of another country, would obviously be right to consult and such a person should seek legal help from an lawyer outside the United States and in the country in which they reside. Seeking legal help from an American lawyer would be unhelpful and such a lawyer should ask the person to consult someone in that country. When it comes to intellectual freedom, privacy and democracy, I believe that librarians should definitely be against breaches of privacy of information in a library, just as the medical community has HIPPPA laws concerning privacy of information. As a future academic librarian, I also believe I should be pro-freedom of information and pro-democracy in an academic library as democracy is something our country was founded upon.
